ASP-3 Update

We are in the soft-launch period of ASP-3 implementation in relation to DBE bid documentation required at time of bid from all bidders. Between October and December 2020, WisDOT will expect all bidders to submit required DBE documents at bid, but no bids will be found non-responsive during this time frame in relation to the DBE submission. We will approach these three lets as an opportunity to optimize our process and work with bidders to further educate them on submission require-ments so that all bids will be deemed responsive when we fully implement ASP-3 in January. DBE Directory Updates



SE Region DBE Stakeholder Advisory Committee

The DBE Office has been collaborating with the SE Region to increase awareness about major projects and emerging opportunities to work with DBE. We are working towards a 2021 launch of the DBE Stakeholder Advisory committee to help build awareness, ca-pacity, and further break down the barriers to entry. We are also focusing on development of a more diverse workforce in the Re-gion and throughout Wisconsin. We will provide information for you in advance of each project networking meeting and hope you will join us!



DBE Program Summary

The DBE program is healthy despite the impacts of COVID-19. Over 120 DBE firms participated on WisDOT contracts with approximately \$24 million in consulting and \$64 million in construction; 1051 subcontracts in construction awarded to small businesses and hundreds of contracts and work orders in professional consulting services. OBOEC also added 30 newly certified DBE firms to the UCP Directory in FY 2020.

Compared to 2019 there was a 30% reduction in Good Faith Effort requests and in June 2020 there were 16 projects with federal funding with no GFE requests for review.

Overall DBE Goal for FFY 2020

The overall DBE Goal for FFY 2020 was set at 12.38% with 11.00% participation anticipated from construction Lets. The DBE goal attained to date is 9.88% in construction or approximately \$64 million with 7.72% race conscious and 2.11% race neutral. The chart and table below depicts the performance of DBE subcontractors on 1051 contracts in construction.

The listings of 94 Contractors, 28 Consultants along with the 30 newly certified DBE firms are found on page 7 thru 10.



Overall DBE Goal for FFY 2021, 2022, 2023

Wisconsin DOT annual overall DBE Goal for Federal Fiscal Years 2021, 2022 and 2023 was approved at 12.41%. Applying the overall annual DBE goal of 12.41% to the annual average of FHWA funding of \$750 million results in a projected average of \$93.1 million in federal highway funds to be made available to certified DBE firms during each federal fiscal year. See Table 2.

Federal Funding Projections

Wisconsin DOT estimates federal funding based on the average annual increases over the life of the FAST Act Transportation bill. FHWA funding is estimated to total \$2.25 billion over the next three years resulting in an annual average of \$750 million in federal funding for DBE contracting opportunities per year. The funds are divided between construction Lets, including the Transportation Alternative Program projects, and consultant solicitations. See Table 2.
