
Spring 2013

The Wisconsin Department of Transportation (WisDOT) is proposing to replace pavement along I-94 from WIS 37 to US 53 in Eau Claire County beginning in 2013 and completed in 2014.

Proposed project details

- Remove existing I-94, WIS 37 and WIS 37 ramp pavements and replace with new concrete pavement. Replace existing WIS 93 ramp pavement with new asphalt pavement.
- Add parallel entrance/exit ramps where possible to allow for greater acceleration/deceleration distances.
- Increase vertical clearance at WIS 37 under I-94 to meet current design standards.
- Widen existing eastbound structures at WIS 37 and County F for traffic control purposes.
- Replace structures at Lowes Creek (east crossing).

Project Schedule:

May 2013: Project Letting

Summer 2013: Construct cross-overs, temporary widening, & replace I-94 westbound pavement east of WIS 93

Fall 2013: Construct temporary widening, replace I-94 eastbound bridge over Lowes Creek, & replace I-94 eastbound pavement east of WIS 93

Spring 2014: Construct cross-overs, temporary widening, widen WIS 37 bridges, & replace I-94 pavement near WIS 37

Summer 2014: Replace I-94 westbound pavement from WIS 37 to WIS 93, replace westbound I-94 bridge over Lowes Creek, & replace WIS 37 northbound pavement

Summer/Fall 2014:

Replace I-94 eastbound pavement from WIS 37 to WIS 93 & replace WIS 37 southbound pavement

Fall 2014: Project complete



Traffic impacts

- I-94 will remain open to traffic during construction.
- I-94 traffic will be single lane (one lane each direction) during pavement replacement east of WIS 93 (Summer/Fall 2013) and near WIS 37 (Spring 2014).
- Temporary lanes will be constructed adjacent to the I-94 eastbound roadway in order to maintain two lanes of traffic each direction during westbound and eastbound pavement replacement from WIS 37 to WIS 93 (Summer/Fall 2014).
- The I-94 eastbound entrance ramp from WIS 93 and I-94 westbound entrance ramp from US 53 will be closed during the summer of 2013. I-94 westbound entrance ramp from US 53 will be reopened by Labor Day.
- Both WIS 93 entrance ramps will be closed in fall 2013.
- All ramps will be open during the winter of 2013/2014.
- WIS 37 entrance and exit ramps will be closed spring 2014 and reopened prior to Memorial Day.
- Detours will be signed for the various ramp closures.
