| NC-01        | 0632-04-00                | Will staff be expected to go to the Region office for this work - or will remote work be allowed?   | It is desired that this position sit in WisDOT offices a couple days a week for training and collaboration; however a fully trained individual who is familiar with WisDOT systems could perform this work remotely.   |
| NC-02        | 9140-12-11                | Will the bridge be designed by the consultant or BOS?   | Consultant; a Structural Engineer will be required.  |
| NC-03        | 9180-17-01                | Will real estate acquisition be needed? Will a plat be needed with design?  | Small amounts of real estate acquisition may be needed, but are anticipated to be limited to TLEs. TLE exhibits may be needed.   |
| NE-01        | 1480-30-00                | Will the exhibits and other items for the preliminary and final scope review meetings, according to the schedule, be the responsibility of the selected consultant?   | Yes. The exhibits for those meetings should be prepared according to the Northeast Region Design Review Process guidance available to consultants in Box. The Region can assist the design consultant with this effort by answering any questions related to preparation of those exhibits. The Region will also assist in preparing the Final Scope Certification document. |
| NE-04        | 4322-10-00                | Please confirm the CEC and DSR dates.   | Some flexibility with those dates depending on contract start, but both are expected by May of 2023.   |
| NW-03        | 7030-00-02,<br>7050-00-04 | Is it intended for the consultant to provide the acquisition for any needed R/W?  | WisDOT staff will be conducting appraisals and acquisitions for this project.  |
| SE-01        | 1320-26-00                | The Project Description within the Solicitation Scope of Services states "WisDOT will also be placing a Thin Polymer Overlay (TPO) on the existing US 12 bridges going over STH 11 just west of Cobb Rd." Will WisDOT be responsible for the design of the TPO and the associated traffic control? Or will the TPO effort be part of the consultant contract? | Consultant   |

| SE-01        | 1320-26-00                | What scope item(s) require a TPP?   | There may be TLE, PLE for the possible culvert repairs/replacement and any associated ditching, and possible placement of riprap.  |

| SE-02        | 2230-11-00                | In the Project Description of the Solicitation Scope of Service, it describes the need for loop detectors for three signal locations to be replaced.
