TAP	Transportation Alternatives Program
	The Transportation Alternatives Program (TAP) is a legislative program that was
	authorized in Fixing America's Surface Transportation Act (or "FAST Act"), the
	federal transportation act that was signed into law on December 4, 2015. With
	certain exceptions, projects that met eligibility criteria for the <u>Safe Routes to</u>
	School Program, Transportation Enhancements, and/or the Bicycle and
	Pedestrian Facilities Program are eligible TAP projects. TAP as a
	reimbursement program that requires local entities to finance the project.
	WisDOT reimburses project sponsors for the federal share of 80% of the
	approved project cost up to the limit of the award.
