Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on two miles of US 51 in Oneida County.


The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

Public input/comments

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process. Included at the end of this handout, as well as on the project website, is a comment form that may be used for written comments regarding the proposed improvements. Project location

The US 51 project extends from Front Street to 3rd Avenue in the towns of Minocqua and Woodruff.



Project purpose and need

The existing pavement was reconstructed or last maintained in 2014 and 2015. The existing pavement is deteriorating with cracking and rutting throughout.

Additional needs include:

- Curb ramps do not meet Americans with Disability Act (ADA) standards
- Between Front Street and Torpy Park along southbound US 51, pedestrians and multimodal uses are not adequately accommodated on the existing narrow asphaltic sidewalks
- At the existing overhead crossing beacon near Lakeview Drive, there are frequent conflicts between the existing push button poles and the snowplows; the existing crossing does not accommodate sight impaired users.

Anticipated benefits

The project is anticipated to provide motorists with a smoother riding surface resulting in less wear on vehicles, extend the service life of the pavement, minimize maintenance costs, provide standard accommodations for handicapped individuals, and improve opportunities for pedestrians and bicyclists.

Proposed improvements

This is a pavement resurfacing project. Proposed improvements include:

- Asphaltic pavement milling and overlay
- Upgrade curb ramps to meet Americans with Disability Act (ADA) standards, where feasible
 - An estimated 40 curb ramps would be upgraded
- Construct new sidewalk and a multi-use path along southbound US 51 from just north of Front Street to Torpy Park
- Improve the existing overhead crossing beacon near Lakeview Drive including relocation of push buttons and addition of audible push buttons for sight impaired users
- Install new pavement marking

Traffic impacts

- Construction is currently scheduled for 2025.
- US 51 will remain open to traffic during construction
 - Motorists can expect to encounter lane shifts and flagging operations with reduced lane width.
 - Pedestrian traffic will be maintained with staging.
- WisDOT will contact homeowners and businesses when working directly in front of your driveway to coordinate daily access.
- Work is anticipated to take place prior to Memorial Day and after Labor Day to avoid peak tourism periods

Real estate

Minor temporary easements are required to accommodate curb ramp and sidewalk replacements and to manage pedestrian traffic around the work areas during construction. Preliminary temporary easements are shown on the exhibits.

A landowner rights pamphlet is available on the project website and WisDOT will contact any impacted property owners directly. WisDOT expects to begin real estate acquisition in Fall 2022.

Parklands

Recreational lands are present in the project area and require consideration during the design process. No work will occur within the parklands at Torpy Park or Veteran's Park. Access will remain to the parklands during and after construction.
