Purpose

Our objective is to gather your input on proposed improvements, discuss traffic management, and other project related information.

Project Information

We are proposing to improve 2.8 miles of US 8.

US 8 is a National Highway System (NHS) route providing connections to the region, state, and nation. US 8 is also a major east - west route connecting local tourism destinations with the rest of the state.

The existing pavement has reached the end of its service life. There are deteriorating drainage elements that are impeding the flow of water from the highway. The railroad crossing is showing severe signs of deterioration.

Proposed improvements include:

- Remove and replace the existing asphalt pavement
- Minor improvements to aid drainage at intersections
- Spot repair of curb and gutter
- Spot repair of storm sewer inlets
- Possible replacement of the existing railroad crossing

Proposed traffic impacts

Construction is currently scheduled for 2024 but could occur as early as 2023.

During construction, US 8 will remain open but flagging operations and single lane closures will be present during much of construction. Access to homes and businesses will be maintained throughout construction. However, temporary driveway closures will be necessary during parts of the construction process. The contractor will contact homeowners and businesses in advance before temporarily closing a driveway.

Real estate

No real estate acquisitions are anticipated at this time.
