#### Purpose of handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements on 5.4 miles of WIS 64 in Langlade County. The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

#### **Public input/comments**

Your comments assist us in developing a project that will serve the needs of the traveling public as well as the needs of the local community and are welcomed and appreciated throughout the design process. Included at the end of this handout, as well as on the project website, is a comment form that may be used for written comments regarding the proposed improvements. #### **Project location**

WIS 64 from approximately 225 feet west of Clover Road in the Town of Antigo to approximately 2,200 feet west of Fifth Avenue Road in the Town of Polar in Langlade County.



#### Project purpose and need

The purpose of the project is to preserve the existing roadway and improve safety by addressing the following: pavement deterioration, accommodations provided by the existing pavement width, substandard guardrail, and a deteriorating culvert crossing.

The existing pavement is showing signs of distress in the form of rutting and various types of cracking. The paved shoulder width in the rural segments of WIS 64 are 3 feet in width which is not wide enough to safely support on-street bicycle traffic. Within the unincorporated community

of Polar, on-street parking is provided but not necessarily desired. The existing beam guard systems do not meet current standards and should be replaced. The end segment of the existing culvert located west of Hanke Rd. is separating from the main section of the pipe.

#### **Anticipated benefits**

If constructed, the project will provide a smoother riding surface which lessens wear on vehicles, extends the life of the pavement, reduces maintenance costs, and improves safety for both vehicular and bicycle traffic.

#### **Proposed improvements**

This is a preservation-level project. Proposed improvements include:

- Milling 2-inches of the existing pavement and paving 2-inches of new Hot Mix Asphalt (HMA) on WIS 64 outside of the community of Polar (rural section).
- Widening the existing 3-foot paved shoulders to 5-foot paved shoulders in the rural sections from County S to the east project limits (total paved and gravel shoulder to remain at 10-feet). The wider paved shoulder will provide for an on-street bicycle accommodation along WIS 64.
- Milling the existing asphalt full depth and paving 6-inches of new HMA pavement within the urban section of the community of Polar.
- Removing and replacing the existing curb & gutter along WIS 64 within the community of Polar. The proposed curb & gutter will be placed to narrow the roadway 4-feet on each side.
  - Narrowing the roadway will eliminate on-street parking but will provide for onstreet bicycle accommodations outside of the vehicle traveled lanes.
- Replace the two existing guardrail installations with new installations that meet current standards.
- Replace the deteriorated end section of the culvert below WIS 64 located approximately 650-feet west of Hanke Rd.
- Remove existing parking lot pavement on WisDOT right-of-way. Existing access points will be maintained.

#### **Traffic impacts**

During construction WIS 64 will remain open to traffic; however, motorists can expect to encounter shoulder closures as well as single lane closures with flagging operations. Temporary driveway closures will be necessary during construction to accommodate milling and paving operations, curb & gutter removal and curing of new curb & gutter.

Access will be maintained to all sideroads, including Mueller Lake Road and the publicly owned lake access point. Similar to WIS 64, single lane closures with flagging operations are anticipated to accomplish sideroad construction.
