ALL INTERESTED PERSONS are notified of the availability of the WIS 23, Fond du Lac to Plymouth projects combined Limited Scope Supplemental Final Environmental Impact Statement/Record of Decision (LS SFEIS/ROD) and the proposal's impacts and effects that has been prepared and filed according to the State and National Environmental Policy Acts.

The LS SFEIS/ROD was prepared in accordance with Title 23, Part 771.125 and Part 771.130(f) of the Code of Federal Regulations (23 CFR 771.125 and 23 CFR 771.130) and Public Law 112-141, 126 Stat., Section 1319(b). The LS SFEIS/ROD, signed on October 15, 2018, is used to address issues of limited scope associated with the overall project.

The LS SDEIS was made available to the public on June 1, 2018 with at comment period that ended July 31, 2018. A public hearing was held on June 19th at UW-Fond du Lac in Fond du Lac, Wisconsin. The draft document identified the Preferred Alternative as the 4-lane On-Alignment Alternative with Corridor Preservation. The Record of Decision now identifies the 4-lane On-Alignment Alternative with Corridor Preservation as the Selected Alternative. Corridor Preservation, in accordance with provisions of Section 84.295(10) of the Wisconsin Statutes, is a planning action that officially maps right-of -way for potential future overpasses and interchanges if traffic needs require the construction of freeway access restrictions.
