## Purpose of the meeting

Welcome to the public involvement meeting for the Racine Street Bridge project.
Our objectives for today's meeting are to:

- Discuss elements of the project that have been updated or changed since the last public involvement meeting.
- Review the selected improvement alternative.
- Present upcoming project activities and proposed construction staging plans.


## Project information

The Racine Street Bridge was constructed in 1952 and is nearing the end of its service life. While the bridge continues to be safe for use by the traveling public, an investigation of the bridge identified a number of issues that need to be addressed. WisDOT recently completed an environmental study that investigated a wide range of improvement alternatives including:

- No-build alternative
- Rehabilitating the existing bridge
- Replacing the bridge at the existing location
- Replacing the bridge on a new location

The selected alternative includes a full reconstruction of the bridge on a slightly different alignment and reconfiguration of both adjacent intersections. Improvements include:

- Increased lane widths and shoulders
- Roundabouts at Main Street and Ahnaip/Keyes Street intersections
- Potential improved vertical clearance for marine traffic
- Accommodations for bicycle and pedestrian traffic
- 2-lane moveable bridge/ 2-lane fixed bridge/roadway
