Purpose of the handout

The Wisconsin Department of Transportation (WisDOT) is in the process of developing plans for proposed improvements at the intersection of WIS 76 and School Road in the town of Greenville in Outagamie County. The purpose of this handout is to provide information on the proposed improvement alternatives, review the design concepts and displays, and obtain input that will assist the department in further development and refinement of a final design.

Project Information

Project location and limits

Project ID 6430-20-00 is located at the intersection of WIS 76/School Road, 0.8 miles south of WIS 15. Construction is currently scheduled for 2024.



Proposed status

- Conducting prelim design and public outreach to help confirm on alternative selection
 - Alternatives include:
 - Reconstructing the intersection with Traffic Signals
 - Reconstructing the intersection with Single lane roundabout

Proposed improvements

- New pavement structure
- Lighting
- Culvert/storm sewer replacement
- · Curb and Gutter
- Signing and pavement marking
- Pedestrian accommodations at the intersection

Right of way needs

Right-of-way acquisition in the form of Temporary Limited Easements (TLEs) and permanent acquisition (FEE) for various locations along the intersection are expected for grading and drainage at the intersection. Some FEE purchase will be required from trail right-of-way in the northwest corner of the intersection in order to realign the trail to better match into the proposed intersection.

Traffic impacts

Final details of traffic control will be determined later in design. It is anticipated the roadway will be closed to through traffic and a detour route will be used. The detour is currently expected to follow WIS 96, County CB, and WIS 15. Local access to property owners and businesses within project limits will be maintained throughout the project.

Schedule

- Finalize alternative selection in summer 2020
- Design is on-going and will continue through summer 2023
- Real estate acquisition is anticipated to begin in fall 2021
- Construction is tentatively scheduled for 2024.

Budget

Construction cost estimated to be \$2,000,000-\$3,000,000

Other planned projects

WisDOT is also working on plans for a reconstruct level project on WIS 76 from Everglade Road to County JJ. Construction of this project is tentatively scheduled for 2025.
