



# WIS 128 Resurfacing Project

## US 12 to WIS 170, St. Croix County

Spring 2023

### Project Description

WisDOT is proposing to improve approximately 7.83 miles of WIS 128 from the intersection of US 12 to the intersection of WIS 170 in Glenwood City in St. Croix County. The existing pavement is exhibiting signs of fatigue in the form of rutting, transverse and alligator cracking. (See project location map on back of sheet.)

Proposed improvements include:

- Recycling 3.75 inches of the existing asphaltic surface in rural section of the project and paving 2.75 inches over the recycled pavement.
- Milling approximately 3.25 inches of the existing asphaltic surface in the urban section of the project and overlaying the roadway with 3.25 inches of hot-mix asphalt in the urban section.
- Placing centerline rumble strips.
- Installing new pavement markings.
- Updating sidewalk curb ramps in Glenwood City.
- Cleaning or replacing culvert pipes.
- Updating guardrail throughout the project corridor.
- Overlaying the deck on a small bridge in Glenwood City.

### Real Estate

Real estate acquisition might be required for curb ramp improvements and culvert pipe and guardrail replacement.

### Traffic Impacts

Construction currently is scheduled to begin in the summer of 2026, work is expected to be completed within 10 to 12 weeks.

During construction:

- WIS 128 will remain open to through traffic for pavement and culvert work, with lane closures controlled by flagging operations.
- WIS 128 may be closed to a single lane of traffic during the bridge deck overlay, with temporary traffic signals controlling traffic.
- Temporary driveway closures may be necessary during parts of the construction process.
  - Construction staff will contact homeowners and businesses in advance before closing a driveway.
  - If you have special access needs during construction, please let us know, so these can be considered as much as possible and, if needed, included in the bidding documents.

### Project Schedule

- July 2023: Environmental review complete
- November 2023: Preliminary design complete
- August 2025: Final design complete
- Dec. 9, 2025: Project is bid
- Summer 2026: Construction
