## WIS 100 - South Section (Layton Avenue to I-94) Public Involvement Meeting #1

### Summary for Meeting in South Section

January 27, 2015

5:00 to 8:00 P.M.

Madison Elementary School

1. The first Public Involvement Meeting (PIM) for the WIS 100 Corridor Study was advertised as one meeting held in two locations. Media sources included a press release, newspaper articles, a project website, e-mail, and a newsletter. The newsletter stated the goal of the meeting was to obtain input on WIS 100 corridor needs. Approximately 5,000 newsletters were mailed. The mailing list included property owners and businesses within an approximate one-quarter-mile distance on each side of the corridor between Layton Avenue and Silver Spring Drive. Members of the Project Advisory Committee for the north and south sections were also sent a newsletter. Members include local officials, major business utility and other stakeholders, state and federal agencies, and American Indian tribes.
2. The meetings had an open-house format. Displays of project information showing corridor information and project purpose and need were available for review. Aerial maps with existing conditions were displayed. Attendees discussed concerns with project staff and had the opportunity to note their concerns directly on the maps at the specific location. Information for both the north and south corridor sections was available at each meeting location. A 6-page project handout and a comment sheet were provided to each attendee.
3. 86 people signed in (team members not included). Most indicated that they were notified of the meeting by:
  - Newsletter
  - Local news sources
  - Social media
  - E-mails from alderperson
4. Project personnel visited the Sales Manager for Mayfair Village and Property Manager for Greenfield Terrace mobile home parks to determine how to distribute newsletters to the residents of the mobile home parks. The property managers provided the unit numbers so that addresses specific to each mobile home could be used as part of the PIM mailing list. Newsletters were mailed to residents on January 22, 2015.

5. A general summary of the verbal and written comments received at the meeting or submitted by mail or e-mail after the meeting is shown below. The comment sheet requested that all comments be submitted by February 10, 2015. A total of 14 written comments were received. The summary reflects comments received by March 4, 2015.
