The Wisconsin Department of Transportation (WisDOT) welcomes you to tonight's meeting for the I-39/90/94 Wisconsin River Bridge Project.

The purpose of this open house is to update attendees about the progress of the project and gather public input. At your own pace, please view the exhibits and talk with project team members, who are here to answer questions and explain project information and proposed improvements.

## **About the Project**

WisDOT is replacing both structures over the Wisconsin River to address deficiencies and the needs of the aging bridges.

The project will also replace structures along County U and County V to accommodate the new structures over the Wisconsin River. Pavement along I-39/90/94, County U and County V will be replaced to accommodate the structure work and construction staging for the project.

WisDOT anticipates that work on the project improvements will begin in 2024, based on the current schedule (see Page 2).




## **Project Schedule**

## **Traffic During Major Construction Stages**


- Throughout construction, **I-39/90/94** will retain three travel lanes in each direction.
- Exceptions may include limited single-lane closures during off-peak travel times, and nighttime rolling and directional full closures for work on bridges at County U and County V.
- County V will have a single, signal-controlled traffic lane over I-39/90/94 during the construction of the new bridge on County V.
- County U will be closed to traffic over I-39/90/94 during construction of the new County U bridge. During the closure, traffic should use WIS 78 as an alternate route.



## **Proposed Construction Staging**


### STAGE 1

- 1-39/90/94 traffic is unchanged
- New northbound bridge and lanes constructed
- County U and County V bridges and roads constructed



### STAGE 2

- 1-39/90/94 traffic shifted to new northbound structure and lanes
- Existing bridges removed
- New southbound bridge constructed

### **STAGE 3**

- I-39/90/94 traffic shifted to final location
- Remove causeway, remainder of existing bridge, and temporary pavement
