#### WIS 33 / Linn Street Village of West Baraboo Proposed Project Plans:

- The project limits are from Mulberry St. to the east Village limits.
- Replace the failing concrete pavement.
- Change from a four-lane roadway to a two lane roadway with a center twoway left turn lane.
- o Replace sidewalk and curb ramps.
- Add street lighting.
- Replace sanitary lines and the water main.

#### WIS 33 / Eighth Avenue and Eighth Street City of Baraboo Proposed Project Plans:

- The project limits are from the west City limits to County T (Taft Avenue).
- Replace the failing concrete pavement.
- Change from a four-lane roadway to a two lane roadway with a center twoway left turn lane.
- o Replace three traffic signals.
- Replace sidewalk, as needed, and curb ramps.
- Replace sanitary lines and the water main.

#### **Traffic impact**

WIS 33 will be detoured during the planned 2024 construction season.

Project Schedule (subject to change)

- **2020** Fall. Complete the preliminary highway design. Fall. Complete the environmental process.
- **2021** Spring. Begin roadway construction plans. Spring. Hold a Public Invovement Meeting.

Finalize Real Estate acquisitions and acquire property. Finalize roadway construction plans.
