Public Involvement Meeting**

Purpose of the meeting

The purpose of this meeting is to gather public input on the identified project needs and proposed improvements. This meeting will follow an online presentation format.

Project information

The proposed project is located on a 13.777-mile section of WIS 58 from 0.7 miles north of County N to Lee Lake Bridge in the Village of Cazenovia. WIS 58 is an undivided, 2-lane rural minor arterial road, with an annual average daily traffic of 1550 vehicles per day.

The purpose of the project is to extend the pavement service life. This roadway was last serviced in 2002. Since then, the road has shown aging and signs of deterioration with alligator cracking and rutting.

Proposed improvements include:

- Highway resurfacing (4-inch mill and overlay asphaltic pavement)
- Widening paved shoulder from 2-foot to 3-foot
- Replacement of curb ramps located at the WIS 58 and County V intersection in Cazenovia to meet ADA standards
- Rehabbing Willow Creek Bridge north of WIS 58 and County D intersection

Proposed traffic impacts

Construction is currently scheduled to begin in Spring 2025 with completion in the Fall 2025.

During construction WIS 58 will be controlled with flagging operations with rolling single lane closures reducing traffic to one lane. During construction access to all properties will be always maintained to the greatest extent possible. Limited access to driveways can be expected during work operations directly in front of these access points. This temporary limited access is anticipated to be infrequent and communicated in advance to property owners. At the end of each day, upon completion of construction activity, WIS 58 will be fully open to traffic.

Sidewalks with curb ramp construction will be closed during construction activity. During which pedestrian detours will be provided to maintain access. All sidewalks will be open upon completion of curb ramp construction.

Real estate

Additional right of way will be required for this project. Temporary easements will be required for curb ramp construction for both curb ramps at the intersection of WIS 58 and County V within the Village of Cazenovia. Information will be sent to affected property owners discussing the temporary easements. No permanent acquisition is expected for this project.
