Purpose of the meeting

The objective of this meeting is to obtain your input on the identified needs and proposed improvements. The meeting will follow an online presentation format.

Project information

WisDOT is proposing to improve 10.5 miles of WIS 60 from County W to WIS 67 in Dodge County.

The purpose of this project is primarily to address deteriorating asphalt pavement on WIS 60. The existing pavement surface throughout the corridor is deteriorated with substantial cracking and rutting. Deficient guardrail end terminals will be replaced in order to improve safety along the corridor. Some damaged and corroded culverts will also be replaced.

Proposed improvements include:

- Mill and overlay asphaltic pavement
- Replace or repair culverts
- Replace deficient or damaged guardrail end terminals
- Replace pavement marking

The environmental document for this project is currently under development by the project team. The environmental document is expected to be completed in early 2021.

Proposed traffic impacts

Construction is scheduled to begin in spring 2023.

During construction, WIS 60 is expected to be closed to through traffic for the duration of the project; however, traffic control strategies are still under development. Traffic using WIS 60 will be detoured to the north using WIS 67, WIS 33, and WIS 26. The final traffic control and staging concepts will be refined by the design team as the project progresses.

Access will be maintained for residents to the greatest extent possible. Limited exceptions to driveway access are expected during work operations immediately in front of access points; however, these times of restricted access are anticipated to be infrequent and well-communicated in advance of any access-restricting work. Specific access needs can be communicated now with the design team or with the Department's field representatives during construction.

Construction is currently scheduled for completion in fall 2023.

Real estate

Real estate acquisitions are not anticipated. All construction activities are expected to remain within existing right-of-way.
