ADDENDUM NO. 01 2475-12-60 August 29, 2016

Special Provisions

7. Utilities

Replace entire section titled AT&T Wisconsin with the following:

AT&T Wisconsin – has facilities within the construction project. A 6-multi-tile-duct (concrete encased and capped) is located STA 481+94 to STA 500+00 30'LT and STA 500+00 to 795+65 15'RT. There are conflicts with the guardrail installation from STA 736+75 to STA 739+00. No conflicts are anticipated at the guardrail installation from STA 786+75 RT to STA 788+75 RT.

AT&T will discontinue the buried copper cable crossing under STH 145 from a pedestal on southeast corner of CTH Y, STA 738+10, 65' LT. A new cable will be installed from STA 738+10 58' LT to STA 739+75 58' LT and crossing under STH 145 minimum 5-ft deep into the existing AT&T manhole structure at STA 740+00 RT.

AT&T will discontinue the 6-MTD package from STA 735+20 RT to STA 740+00 RT. AT&T will bore 6-4"-pvc conduits starting at STA 735+20 tieing into the existing AT&T manhole at STA 740+00 16.5' RT. Bore path will be 2 ft off the existing ROW line, at 31' RT.

Elevation varies between elev 865 to 870, following 5 ft depth along the bore path. Crossing under guardrails to the manhole at STA 740 will be at elevation 865, clearing min 3 ft deep from the bottom of the existing ditch line. Min 6 ft deep at guardrail posts.

Contact AT&T 5 days before guardrail installation at STA 736+50 to STA 740+00 RT. AT&T will remove any concrete encased conduit that is in conflict with guardrail post installation. AT&T will require 10 days to complete the removals and restoration. The WisDOT contractor will remove the asphalt shoulder and asphalt curb, and will mark guardrail post locations prior to AT&T removals. AT&T contractor will remove any concrete conduit in conflict with guardrail post installation. AT&T will dispose of concrete and debris removed. AT&T will fill any voids from removals with granular backfill to the original grade.

All erosion control devices shall be placed by WisDOT contractor.
