47. Lateral Connection Sealing, Item SPV.0060.28

Replace the first sentence under C.2 Televising with the following:

Television inspection is required prior to sealing and is limited to a "Quick Pull".

54. Sanitary Sewer Cured-In-Place Liner, Item SPV.0090.12

Revise the first sentence under **B.1.6** (8) with the following:

Contractor must submit design data and cured-in-place pipe liner thickness for each run of pipe from manhole to manhole to the engineer prior to installation.

Delete the second sentence under B.1.6 (8).

Revise the title of **B2.3 Post Lining Submittals** to the following:

Pre and Post Lining Submittals

Revise subsection (2) of B2.3 to the following:

Pre lining CCTV tapes and reports per section C.5.5.

Replace first sentence under C.1 Examination with the following:

Televise the existing pipes and review tapes prior to starting lining operations. Previous televising records of the existing pipes can be obtained by contacting Paul Brauer at the NE Region office, telephone = 920-366-1097.

Replace the subsection (1) of C5.5 CCTV Examination with the following:

Televise interior of pipes prior to start of work and provide tape to City of Sheboygan; Ryan Sazama, Telephone = 920-459-3485.

Remove the last sentence under E Payment.

56 Televising Sanitary Sewer, Item SPV.0090.17

Replace the first sentence under C.1 Procedures with the following:

The intent of closed circuit televising inspection (CCTI) is to observe and record the condition of the sanitary sewer sections being either lined or installed after the lining and installation is completed.
