Special Provisions

3. Prosecution and Progress

Insert the following section titled Interim Completion Dates after the fifth paragraph:

Interim Completion Dates

Complete all contract work with all lanes of all roadways open to through traffic, except for permanent pavement marking and overhead sign support materials associated with delayed deliveries (poles, arms, and overhead signs), prior to 12:01 AM November 28, 2019. Concrete bases without poles shall be protected by the contractor at their cost.

If the contractor fails to complete all contract work, except for permanent pavement marking and overhead sign support materials associated with delayed deliveries (poles, arms, and overhead signs), and all lanes of all roadways open to through traffic prior to 12:01 AM, November 28, 2019 the department will assess the contractor \$1540 in interim liquidated damages, for each calendar day that the roadways remain closed after 12:01 AM, November 28, 2019. An entire calendar day will be charged for any period of time within a calendar day that the roadways remain closed beyond 12:01 AM.

Complete installation of all permanent pavement marking and overhead sign supports (poles, arms, and overhead signs) prior to 12:01 AM April 16, 2020.

If the contract time expires prior to completing all work specified in the contract, additional liquidated damages will be affixed according to standard spec. 108.11.
