ADDENDUM NO. 01 3876-05-71 November 23, 2020

Special Provisions

18. DELETED

28. Gates Chain Link 4-FT Polymer Coated, Item SPV.0060.37.

A Description

This special provision describes furnishing and erecting polymer coated gates at locations shown on the plans or as directed by the engineer, and as hereinafter provided.

Perform this work according to standard spec 616 except as herein after modified.

B Materials

Furnish all fence and gate materials according to standard spec 616 and according to the details shown in the plan. Gates and fence materials shall be chain link and according to standard spec 616.2.1 and 616.2.3 and polymer coated. The polymer coating shall be a dense impervious covering, applied without voids, tears or cuts that reveal the substrate. Excessive roughness, bubbles, blisters and flaking in the polymer coating will be a basis for rejection.

Provide polymer coating over zinc coating on all components that conforms to ASTM F626 and F1043. The color of polymer coating shall be dark green, conform to the requirements of ASTM F934, and match the color of the other fence components.

C Construction

Construct the gate according to standard spec 616.3.1 and 616.3.3.

Deliver material to the site in an undamaged condition. Upon receipt site at the job site, all materials shall be thoroughly inspected to ensure that no damage occurred during shipping or handling and condition of materials is in conformance with these specifications. If polymer coating is damaged, contractor shall repair or replaced components as necessary to the approval of the engineer at no additional cost to the department. Carefully store material off the ground to ensure proper ventilation and drainage and to provide protection against damage caused by ground moisture. Handle all polymer coated material with care.

For minor damage caused by shipping, handling or installation to polymer coated surfaces, touch-up the finish in conformance with the manufacturer's recommendations. Provide touch-up coating such that repairs are not visible from a distance of 6-feet. If damage is beyond repair, the fencing component shall be replaced at no additional cost the department. The contractor shall provide the engineer with a copy of the manufacturer's recommended repair procedure and materials before repairing damaged coatings.

Install the gate according to ASTM F567 and the manufacturer's instructions. The contractor shall provide staff that is thoroughly familiar with the type of construction involved and materials and techniques specified. Heads of bolts shall be on the side of the fence adjacent to pedestrian traffic.

D Measurement

The department will measure Gates Chain Link 4-FT Polymer Coated as each individual unit, acceptably installed and completed.

E Payment

The department will pay for measured quantities at the contract unit price under the following bid item:

Payment is full compensation for furnishing and installing all materials including polymer coating, excavation and removing all excess excavation; for setting posts including placing concrete; for erecting and tensioning all fencing components; for providing the gate; for completing any touch-up and repairs; and for all bolts, hardware, and other connection pieces found in the plan.




