NOTICE TO CONTRACTORS**

BIDDERS MUST SUBMIT BIDDING PROPOSALS NO LATER THAN 11 A.M. LOCAL TIME, TUESDAY, SEPTEMBER 14, 2021, to the Division of Transportation System Development for the highway work hereinafter described. PROPOSAL GUARANTY
