Section 11-1 ...... Introduction Updated contact information in 11-1. Updated the definition of the row titled "Reconstruction" in Attachment 10.1.

#### Section 11-4 ..... Reports

Updated guidance in 11-4-3 Final Scope Certification (and Attachment 3.1) and in 11-4-10 Design Study Report. Eliminated Attachments 10.2, 10.2, 10.4. The previous Attachment 10.5 is now 10.1, and the previous Attachment 10.1 is now 10.2. Latter attachments have the same guidance but are renumbered. There are some edits to the guidance in the new Attachments 10.1 and 10.2 too.

Section 11-5 ......... General Design Considerations Added a heading, 11-5-3.2 Congestion and LOS, and removed guidance to other references under 11-5-3.1.

#### Section 11-10 ..... Design Controls

Added references to the Traffic Engineering, Operations and Safety Manual for design speeds. Modified language to be consistent with other sections and policies for setting speed limits.

Section 11-15 ...... Cross-Section Elements for Modernization Projects on Rural Highways, Freeways and Interstates Updated guidance under 11-15-1.7 Shoulders. Updated guidance to match updates to SDD 13c11-14a in 11-15.1.7.1 Shoulder Paving Policy. Added new Attachment 1.19, Design Considerations for Various Shoulder Treatment Options in Areas of High Side Superelevation. Removed design speed reference within Attachments 1.1, 1.2, and 1.3.

Section 11-20 ...... Cross Section Elements for Modernization of Urban Highways Updated reference to the Traffic Engineering, Operations and Safety Manual when selecting design speeds. Updated design speed reference within Attachments 1.1 and 1.5.

Section 11-25 ...... Intersections at Grade

Updated references to "A Policy on Geometric Design of Highways and Streets, 7th Edition, 2018," commonly referred to as the Green Book.

### Section 11-26 ...... Roundabouts
